SOCIAL DISTANCING INTRODUCTION

The Social Distancing Protocol identifies types of social distancing, assesses the probable economic and social impact of each measure, and provides a guide for phased implementation based on WHO pandemic phase and local surveillance. This document constitutes a model for SPORT EVENTS that want to be proactive about planning a layered approach to social distancing in a community. It may be important to ensure that these materials, especially those pertaining to social distancing thresholds, correspond with Regional guidance.

HOTEL MEASURES:

Not all the Hotels will be allowed to host guest during the pandemic, for this reason Rally di Roma Capitale has created a booking service with the aim of making the life easier to all the teams coming from abroad.

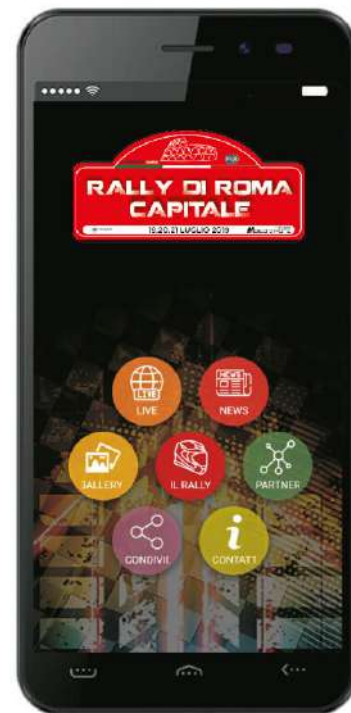
OUR APP:

Motorsport Italia SPA, has created a dedicated app since 2018.

One of the most important tools of this application was the Live section.

Thanks to this section the user was able to virtually access at each one of the special stages and overlook at all the SPECTATOR AREAS.

With a simple click on the spectator areas of your interest, the App was able to give you the map to arrive at this point.



2020 APP:

In 2020 our app has become a real platform, accessible by app and web site, will be implemented with a «Access Pass Feature» able to release an «access pass» to the registered user for a specific AREA.

It must necessarily be used by everyone. Thanks to the use of our platform we will have the opportunity to know the entrances and exits and make sure there is no overcrowding.

Through the platform you can get the "Access Pass" for certain areas depending on the category you belong to.

A maximum number of registrations may be made per category.

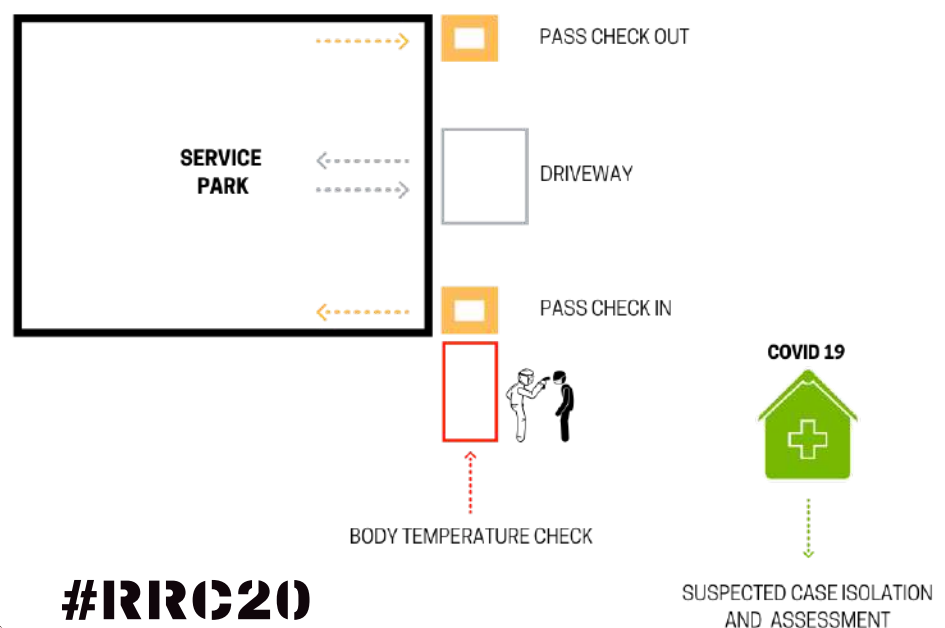

THE PROCEDURE FOR REQUESTING SPECTATOR PASSES SHALL BE ACTIVATED AS SOON AS PERMITTED BY THE COVID-19 EMERGENCY REGULATIONS.

HOW IT WILL WORK THE TEAM SECTION:

STEP 1: After registering in the rally, the team will receive a Passcode that will allow them to complete the pass registration on our APP/Site. After completing all the mandatory boxes including but not limited to Name, Surname, ID Number, Nationality, etc. the APP/Site will ask to tick some boxes related to COVID 19 Protocol and only after pressing the OK sign, the APP/Site will release an Access Pass. The TEAM pass will allow the entrance ONLY at the service park. Access to the HQ is prohibited for each team member. In case of need, an individual day pass will be issued at the request of the COC/Clerk of the Course/Stewards/Scrutineers.

STEP 2: Complete list of TEAM members receiving pass will be given to our COVID Manager who will double check them with local health organization to make sure no-one requiring pass is affected by Quarantine restriction.



HOW IT WILL WORK THE TEAM SECTION:

STEP 3: To access the service area will be mandatory passing through the Medical Checks where a Medical Chief will check body temperature and will make sure everyone has a protective mask. Service park Manager will have a scanner able to read the access passes. Only team members without COVID symptoms, with a valid access pass and with a paper self-certification that attests their state of health (we will send you a form to fill out) will be allowed to access the SERVICE PARK.

The use of a protective Mask will be mandatory all the times team members are outside their area or anytime that will be impossible to respect the social distancing of 2 mt.

HOW IT WILL WORK THE TEAM SECTION:

STEP 4: Every time a team member will exit from service park must check out at the the exit point and in the case he will came back later he should check in again following STEP 3 procedure. The App will register time in and out of any team member entering/exiting the area. In case one pass holder will show COVID Syntoms in the 15 days after the rally, we will be able to track each one of the team member that come closed to him in a specific area.

STEP 5: Pass holder will receive a push message on his mobile every day for 15 days asking about health conditions. Also in this case we foresee two options:

A: If noone will show COVID symptoms, in compliance with the rules contained in the GDPR within 15 days from the end of the event, the Organization will undertake to delete any sensitive data (name, surname, telephone number, etc.) including data about entrances/exits from the areas.

B: If one or more pass holders will show symptoms we will ask them to contact our COVID Manager and all data recorded from the app will be given to the health organization to prevent the spread of the VIRUS. At the same time the other pass holders will be invited to contact their doctor at the occurrence of symptoms. At the end of this procedure all the data in our possession will be deleted.

HOW IT WILL WORK THE MEDIA SECTION:

STEP 1:

Send the email to press@rallydiromacapitale.it with Name, Surname, Nationality and Job/Journal to request a passcode to access the system.

The Passcode will allow MEDIA persons to complete the pass registration on our APP.

After completing all the mandatory boxes including but not limited to Name, Surname, ID Number, Nationality, Area, etc. the APP will ask to tick some boxes related to COVID 19 Protocol and only after doing so, the APP will release an access Pass valid as media accreditation.

MEDIA pass will allow the entrance ONLY in the MEDIA ZONE.

Entrance in PRESS ROOM will be allowed only to 20 invited MEDIA personel who will receive an additional pass.

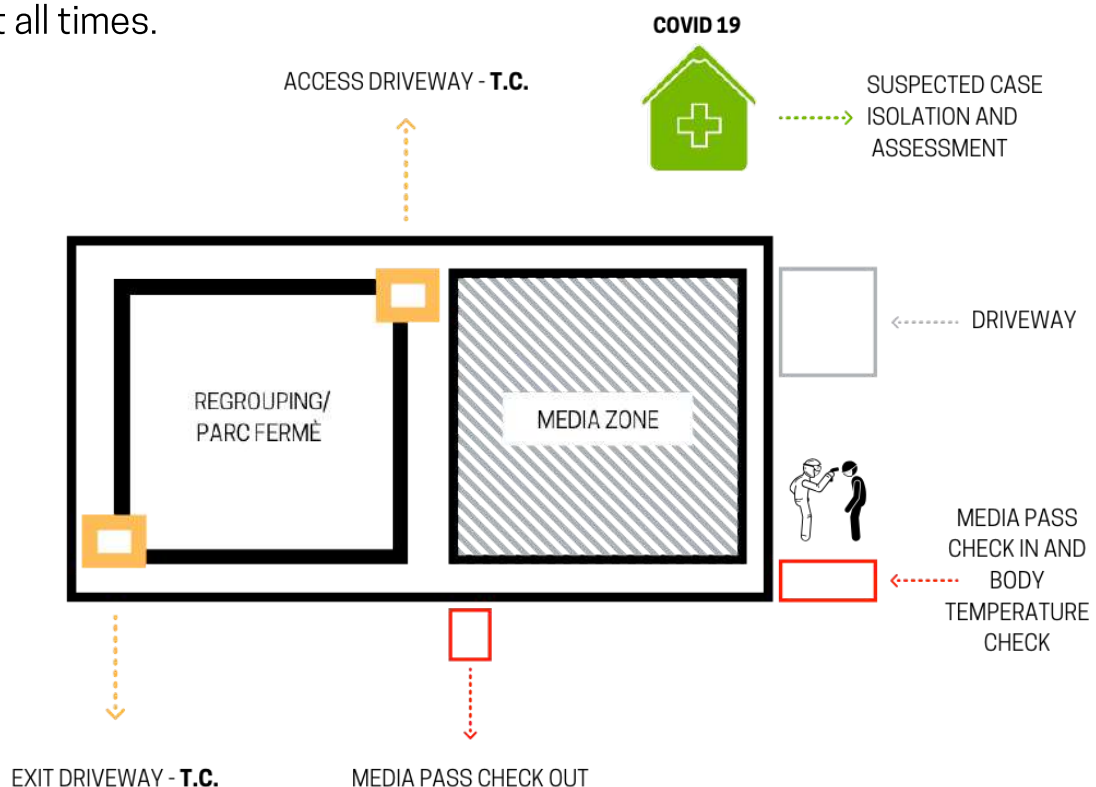

HOW IT WILL WORK THE MEDIA SECTION:

STEP 2: complete list of MEDIA personel receiving pass will be given to our COVID Manager who will double check them with local healt organization to make sure no-one requiring pass is affected by Quarantine restriction.

STEP 3: To access the MEDIA ZONE will be mandatory passing trough the Medical Checks (an additional mediactal checks will be in place at the entrance of the PRESS ROOM) were a Medical Chief will check body temperature and will make sure everyone has a protective mask. MEDIA ZONE Manager will have a scanner able to read the access passes. Only MEDIA staff without COVID symptoms holding a valid access pass and a paper self-certification that attests their state of health (we will send you a form to fill out) will be allowed to access the area.

The use of a protective Mask and 2 mt social distancing will be mandatory at all times.



HOW IT WILL WORK THE MEDIA SECTION:

STEP 4: Every time the MEDIA staff will exit from the area must check-out at the the exit point and in case he will came back later he should check in again following STEP 3 of this procedure. The App will register time in and out of any MEDIA staff entering/exiting the area. In case one pass holder will show COVID symptoms in the 15 days after the rally, we will be able to track each one of the member that come closed to him in a specific area.

STEP 5: Pass holder will receive a push message on his mobile every day for 15 days asking about health conditions. Also in this case we foresee two options:

A: If noone will show COVID symptoms, in compliance with the rules contained in the GDPR within 15 days from the end of the event, the Organization will undertake to delete any sensitive data (name, surname, telephone number, etc.) including data about entrances/exits from the areas.

B: If one or more pass holders will show symptoms we will ask them to contact our COVID Manager and all data recorded from the app will be given to the health organization to prevent the spread of the VIRUS. At the same time the other pass holders will be invited to contact their doctor at the occurrence of symptoms. At the end of this procedure all the data in our possession will be deleted.

HOW IT WILL WORK THE SPECTATORS SECTION:

STEP 1: After measuring each spectator area Motorsport Italia will determinate how many spectators could access each one of the areas respecting social distancing measures. For example area of 500m² will be accessible to a maximum number of 50 spectators.

STEP 2: A spectator that would like to see the rally in one specific area should enter in the App, click on the area he would like to access and complete the Registration feature.

STEP 3:

A: if there are still space available in that SPECTATORS AREA the APP will ask to tick some boxes related to COVID 19 Protocol and only after pressing the OK sign, the APP will release an Access Pass. In addition, you will receive an email containing the self-certification form to be completed and delivered by hand.

B: if there is no space available in that area the APP will show available Spectators area.

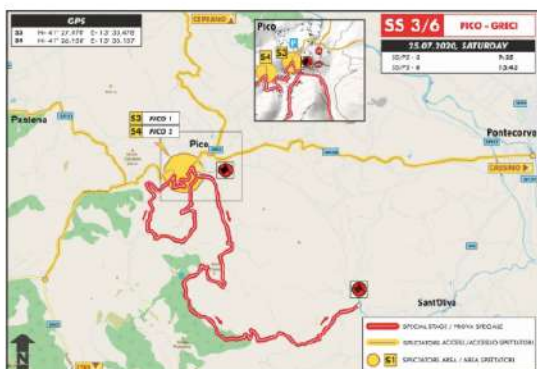

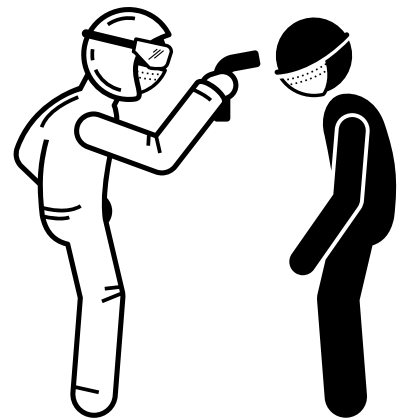

HOW IT WILL WORK THE SPECTATORS SECTION:

STEP 4: Complete list of admissions will be given to our COVID Manager who will double check them with local health organization to make sure no-one requiring pass is affected by Quarantine restriction.



STEP 5: The day of the rally each spectator area manager will have a scanner able to check body temperature and read the Access Passes. Only spectators without COVID symptoms, wearing a protective mask, holding a valid access pass and a paper self-certification that attests their state of health (we will send you a form to fill out) will be allowed to access the area.

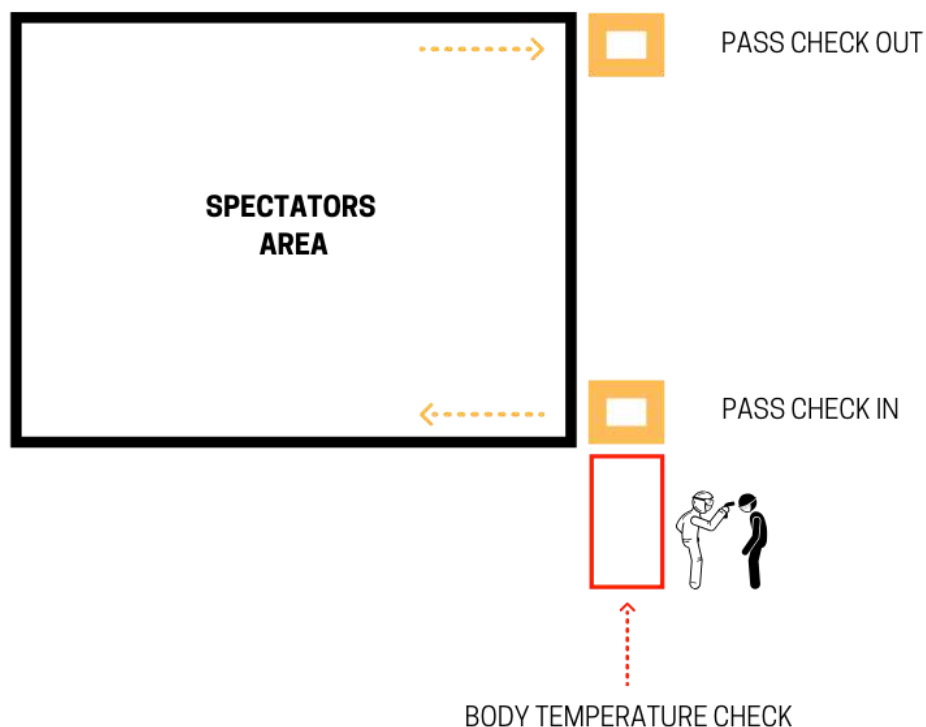
THE PROCEDURE FOR REQUESTING SPECTATOR PASSES SHALL BE ACTIVATED

STEP 6: The App will register time in and out of any spectators entering in order to know perfectly the number of participants and their positioning in the different areas.

This will allow us to ensure that we do not have any overcrowding, and indeed maintain social distancing.

Furthermore, in case a spectator should show COVID symptoms in the 15 days after the rally we will be able to invite spectators in the same area to monitor their health.

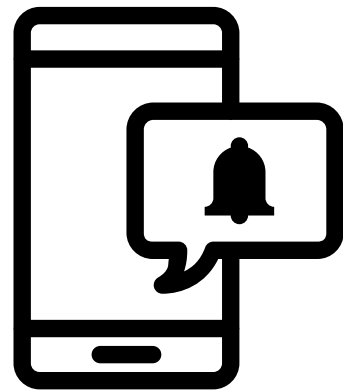

THE PROCEDURE FOR REQUESTING SPECTATOR PASSES SHALL BE ACTIVATED AS SOON AS PERMITTED BY THE COVID-19 EMERGENCY REGULATIONS.

STEP 7: Spectator will receive a push message on his mobile every day for 15 days asking about health conditions. Also in this case we foresee two options:

A: If noone will show COVID symptoms, in compliance with the rules contained in the GDPR within 15 days from the end of the event, the Organization will undertake to delete any sensitive data (name, surname, telephone number, etc.) including data about entrances/exits from the areas.

B: If one or more spectators will show symptoms we will ask them to contact our COVID Manager and all data recorded from the app will be given to the health organization to prevent the spread of the VIRUS. At the same time the other spectators will be invited to contact their doctor at the occurrence of symptoms. At the end of this procedure all the data in our possession will be deleted.



HOW IT WILL WORK THE MARSHALS SECTION:

STEP 1: Each group must register on the platform through the App or Site and enter the data of each marshal. After completing all the mandatory boxes including but not limited to Name, Surname, ID Number, Nationality, Area, etc. the APP will ask to tick some boxes related to COVID 19 Protocol and only after doing so, the APP will release an access Pass and a self-certification form to be completed and delivered by hand.

STEP 2: Complete list of Marshals will be given to our COVID Manager who will double check them with local health organization to make sure no-one requiring pass is affected by Quarantine restriction.

STEP 3: On the morning of the meeting all the Marshals will have to deliver to the Chief Marshal the self-certification the full filled self-certification form. At the Special Stages entrance everybody will be subjected to medical examination of body temperature.

HOW IT WILL WORK THE MARSHALS SECTION:

STEP 4: At the end of the medical check the Chief Marshal will check-in all the Passes and will hand over bib and medical devices to everyone to all those without it.

STEP 5: Marshals/workers will receive a push message on his mobile every day for 15 days asking about health conditions. Also in this case we foresee two options:

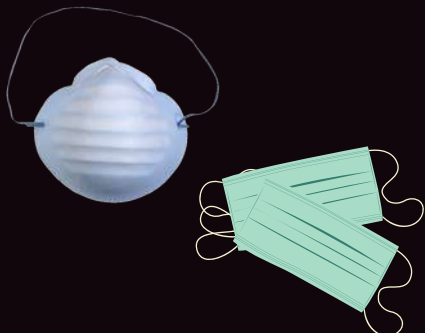
A: If noone will show COVID symptoms, in compliance with the rules contained in the GDPR within 15 days from the end of the event, the Organization will undertake to delete any sensitive data (name, surname, telephone number, etc.) including data about entrances/exits from the areas.

B: If one or more marshals/workers will show symptoms we will ask them to contact our COVID Manager and all data recorded from the app will be given to the health organization to prevent the spread of the VIRUS. At the same time the other marshals/workers will be invited to contact their doctor at the occurrence of symptoms. At the end of this procedure all the data in our possession will be deleted.

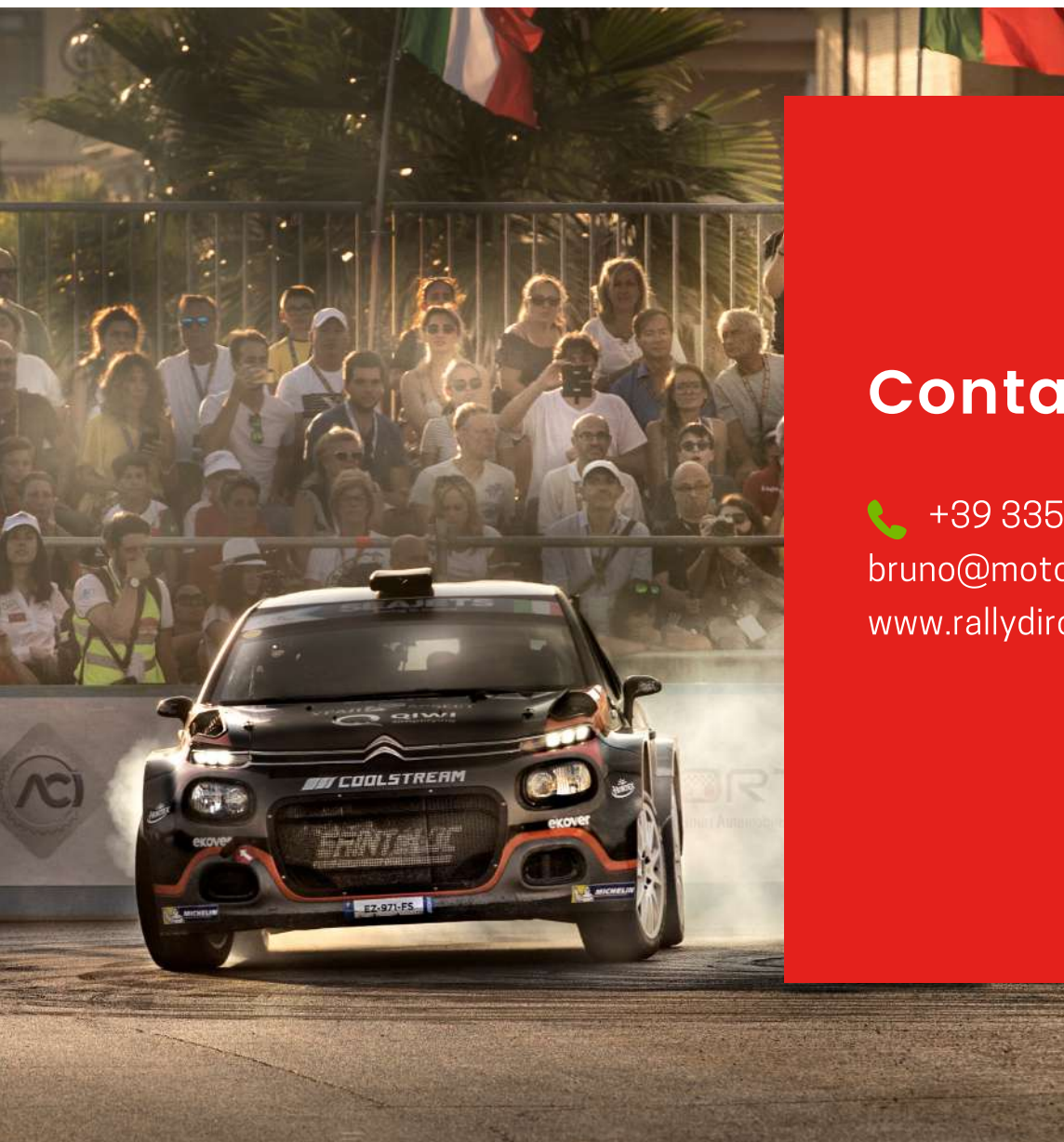
SMART WORKING DURING RALLY DI ROMA CAPITALE

- Admin checks and Material's delivery including GPS/Numbers/Roadbook will be made on appointment. Will be allowed the presence of a team member only. All the necessary documents should be sent to the organizers by email at least 10 days before the admin checks;
- TM briefing will be made via webex or similar;
- Technical scrutineering should happen under the team tent. Car should be on the stands without sump-guard ready to be sealed. Spares and safety gears should also be ready at the same time and in the same area. The use of masks will be mandatory at all time during scrutineering. A weight area will be prepared inside the service park to allow any team to check car weight in a 3 hours window.
- Start and Finish of the rally will be held following Federation protocols.
- At TC drivers should maintain social distancing and wear a mask/balaclava and gloves;
- Media Zones: will be forbidden for any team member to travel and attend at the media zones/regrouping. The access to those areas will be allowed only to registered MEDIA personnel wearing a mask.
- All documents will be sent via WhatsApp / email and published on the web site.
- Access to HQ will be forbidden to any team member. In case will be requested from Stewards or COC a day pass will be issued.

TREATMENT OF A SYMPTOMATIC CASE DURING RALLY DI ROMA CAPITALE

Anyone who might feel COVID symptoms during the event should follow this procedure:

- STOP immediately any kind of work;
- Immediately inform the COVID manager of the Rally about the symptoms;
- Implement social distancing to 3 meters from any other person;
- Walk following the shorter way to the COVID 19 tent where the medical staff will treat the case following the procedure n. 5443 del 22 Feb 2020;
- The medical chief of that area will write a report and will submit this to the COVID manager;
- If the situation require further medical assistance the COVID manager will arrange transportation to the nearest COVID hospital with a COVID ambulance;
- The COVID manager will arrange as quick as possible a test to the patient;
- If recovery to an hospital is not requested by the medical chief, the patient should go home immediately avoiding any public transportation and prior informing people at home so that a safe quarantine room could be prepared in time for his came back.
